## A NOTE FROM OUR CEO,

The year 2023-2024 was another year filled with milestones and achievements for your Chamber. To highlight them all would be impossible, but here are some of my favourites.

Our events, whether they be of the networking variety (Business After 5) or celebratory (Business Achievement Awards) continue to be enthusiastically embraced by the community. We welcomed almost 1,100 guests to RBC Place in September. Business After Five has grown into one of the must-attend events of each month and attendance has soared. The crowds are bustling, they are diverse and they are engaged.

We also welcomed over 170 new members to the Chamber. That's an incredible figure. And there were lots of reasons folks were joining: events, networking, exposure, training and to support our advocacy work. But there was a new reason. When we distributed our annual survey to the members asking, among other things, why they are members, we asked a new question: "Is it because of the work we do in the community?" And almost two-thirds of the respondents ticked that box - the second highest after networking.

This was also the year that we launched our ground-breaking partnership with the Canadian Black Chamber of Commerce. This is the first dual membership of its kind offered in Canada between Chambers of Commerce.

We have a shared mission to diversify your network, market interests, and available resources to help you reach and connect with like-minded entrepreneurs. Our dual membership offers businesses many benefits, such as expanding their business, increasing their network, and accessing valuable resources to boost their business.

Waived Membership Fee: Any Black-led business or organization that joins the London Chamber of

Commerce is eligible to receive a Canadian Black Chamber of Commerce membership at no extra cost. As a member of the London Chamber of Commerce, you have the option (but not obligated) to receive a CBCC membership automatically and become a "Joint Member."

Additionally, the LCOC will waive the \$250 membership fee associated with the CBCC membership program – should a CBCC member wish to join our membership program.

We proudly offer a benefits package that allows you to experience the best of both worlds, maximize your business potential, and broaden your network. Together, we can create a thriving business ecosystem that supports diversity, innovation, and prosperity.

This year we also introduced a brand new 'Ask the Experts" series. These are monthly workshops led by successful, knowledgeable professionals who are eager to pass on their expertise to other business owners. Each session features a keynote speaker and a panel of professionals who discuss topics such as Artificial Intelligence, Leadership, Marketing, Black Entrepreneurship; Indigenous Allyship in the workplace and Human Resources. Attendees have the chance to engage directly with the experts, ask questions, and gain helpful insights. The Ask the Experts series ties in with one of our goals in our strategic plan - to provide strong and impactful member services.



The Chamber continued to centre much of its efforts in the Equity sphere on Indigenous Reconciliation. In addition to our continuing program with the Southern First Nations Secretariat (through which we support their Job Bank and Business Directory), we have launched a brand new initiative with NoKee Kwe called "First Employ".

In the spirit of truth and reconciliation, Nokee Kwe, the London Chamber of Commerce, the City of London and Libro Credit Union have come together to create the First Employ Project.

This Indigenous-led initiative is focused on leveraging the strengths of Indigenous Peoples and fostering inclusive economic growth. The business community has obligations under Call to Action 92 from the Report of the Truth and Reconciliation Commission. This project is designed to assist businesses meet those obligations by laying out clear, actionable steps towards meaningful economic reconciliation.

A key component of the First Employ Project was our sold-out, special edition of "Ask the Experts": Indigenous Allyship in the Workplace". Our speakers offered clear, actionable steps towards meaningful economic reconciliation.

For example, we discussed how businesses can:

1. Enhance hiring norms and promote culturally safe work environments?

2. Align their operations with the principles of equity, respect, and partnership?

3. Enhance employment prospects for Indigenous individuals?

4. Promote dialogue between Indigenous community members and business leaders on economic reconciliation and inclusivity within the workplace?

There will be lots more to follow on.

Our Community Outlook event this year featured a look at Employee Ownership.

Guests joined us at the Wolf Performance Hall to discover the power and importance of Employee Ownership. We heard from Geoffrey Smith, CEO of

## MESSAGE FROM OUR BOARD TREASURER

The Financial year ended June 30, 2024, marking the end of three years of intensive work and investment in the Chamber, its members, and its staff. While the Chamber ran a planned deficit for the fiscal year that ended June 30, 2023, the Chamber budgeted for an operating surplus in 2024, which for the year that ended June 30, 2024, was \$23,552.

The Chamber has continued to experience a significant increase in membership revenue over the last year, increasing from approximately \$400,000 for the year end June 30, 2023, to \$528,00 for the year ended June 30, 2024. This membership growth has also strengthened engagement at key events such as the BAA's, State of the City, and the Business After Five events throughout the year, which resulted in \$415,00 of revenue. On behalf of the board, I want to thank the staff and volunteer committees that make these and all events at the chamber a great success for our members.

The revenue generated continues to be re-invested in our members as we honour our Mission, Vision, and Values as we work to support our three pillars: (1) Strong and Impactful Member Services; (2) Effective Operations and Governance; and (3) Economic Prosperity and Social Progress in our community.

During the year, the Chamber was able to take advantage of \$20,000 from CEBA loan proceeds and has been able to improve the working capital position, by monitoring collections and payable amounts owing in a timely manner. Following a year of significant investments in IT, infrastructure, and leasehold improvements last year, 2024 was about leveraging those investments to optimize processes, create an engaging and vibrant place to work for our staff, and invest in meaningful and value-driven events for our members. It is my pleasure to be able to present you with this report and I thank you for the opportunity to have served the Chamber this past year as Treasurer.

## ADVOCACY

## The 2023-2024 year has been another significant one for the London Chamber of Commerce, particularly on the advocacy front.

#### **Provincial Level:**

The London Chamber has actively advocated for expanding access to Employment Ontario. We specifically recommended that the Ontario Government extend eligibility for the full suite of Employment Ontario programs to international students, graduates, and individuals on temporary visas, such as those on spousal visas with work authorization.

#### Federal Level:

At the federal level, the London Chamber proposed key changes to the Artificial Intelligence and Data Act, aiming to keep Canada competitive with its major trading partners in AI regulation. We also authored a comprehensive paper on restoring Canada's fiscal balance and right-sizing government, offering recommendations to curb the nation's debt/deficit and reassess spending across all ministries. Additionally, the Chamber has been vocal about urging the federal government to take decisive action to prevent or minimize the impact of rail strikes and lockouts, ensuring the health of Canada's supply chain.

#### Municipal Level:

Locally, the Chamber has supported the City of London's Health and Homelessness Initiative, backing efforts to address the city's homelessness and addiction crises.



## ADVOCACY

## Some other policy highlights and wins include:

The federal Fall Economic Statement included two major items we have advocated for: a commitment to labour mobility and credential recognition (a long-standing policy resolution from the Canadian Chamber Network) and commitments to expedite the roll-out of Investment Tax Credits from Budget 2023 (which we advocated for in October in response to member concerns).

In September 2023, the Prime Minister announced that MP Jennifer O'Connell (Pickering-Uxbridge) will take on the role of Parliamentary Secretary to the Minister of Public Safety, Democratic Institutions and Intergovernmental Affairs (Cybersecurity). This is the first time there has been explicit reference to cybersecurity in the role and the addition is directly tied to our positions

Following broad advocacy, including over 250 members of the Canadian Chamber Network and other partners, the government announced a further year's extension to the CEBA loan repayment deadline, a further quarter's extension to qualifying for the forgivable component, and a new three-year sub-prime loan (5%) for those unable to refinance or pay off their loans now.

In a letter to Minister Stephen Lecce the Chamber Network called to expand financial literacy with the educational curriculum. In May 2024 Minister Lecce announced the introduction of Canada's first financial literacy graduation requirement that will ensure students exit Ontario's school system with both literacy and financial literacy skills.

In our 2024 Provincial Budget Submission, we called on the Ontario Government to take bold national leadership on interprovincial trade by signing mutual recognition agreements to promote trade and labour mobility. In July 2024, the Government of Ontario signed a Memorandum of Understanding with the Government of Alberta. The provinces will work together to share expertise and information and explore an international credential recognition framework for skilled trades that will enhance this process and support mobility between both jurisdictions.

Often referred to as the "Academy Awards" of business excellence in London, the annual Business Achievement Awards gala highlights and honors exceptional businesses within the London community. As the largest business awards event of its kind in Canada, the Business Achievement Awards attracts over 1,200 attendees.

#### **State of the City Address**

January 2024

The State of the City Address is a one of a kind event that marks the beginning of a new year. It sets the tone for both Mayor and Council as they set out to tackle the important issues that face our municipality. It has become a must-attend event for the London business community.

#### London City of Music Expo March 2024

The London City of Music Expo celebrates London's unique status as the only UNESCO designated City of Music in Canada, while showcasing how music contributes to our local economy, our community, and our culture.

#### Summit June 2024

Summit is an event where local speakers share their incredible journeys of 'scaling up' their businesses. This event is designed to motivate and empower the London business community to reach unprecedented heights in their business growth strategies.

#### Past Chairs' Golf Classic June 2024
